

**Press Statement on Linyungandambo Childishness**

The Executive Committee of the Barotse National Freedom Alliance (BNFA) has taken note of the futile attempts by a section of the Linyungandambo grouping to water down its relevance to the achievement of the real liberation of the people of Barotseland leading to actualization of a separate and free-state of Barotseland. In particular, the hate campaign against Mutompehi Wainyae Sinyinda by social and political misfits who unwittingly are serving the interests of the enemies of Barotseland should be very clear to all right thinking and discerning people and, for this reason, the BNFA has not paid much attention to the Linyungandambo childish behavior up to now.

In line with this stance of restraint to wasting of ammunition on pigeons while elephants roam, this press statement is being made to reiterate the point that it is not the BNFA's policy to be drawn into a protracted but yet diversionary war of words with people whose mission is to ensure that real work for achieving a free Barotseland is abandoned in favour of a 'make believe' liberation under a 'government-in-waiting' which is designed to wait forever. BNFA looks and works for tangible liberation as opposed to fake declarations of independence made from hiding places by dimwits who immediately turn around *kulusikisa lubilo* leaving their 'liberated' citizens in the hands of Zambia Police and Zambian Judiciary to continue to preside over the affairs of the same people who have declared Barotseland free and have sworn themselves as Administrator-Generals, whatever this means. Liberation of a country *a kitaba ya mandwani* and is never achieved by empty pronouncements but takes effect only after institutional evolution of governance structures as well as internationally recognized statutory establishment of sovereign entity within the territory being declared independent. The foregoing may sound as Greek to the ears of people who have no idea of how states are formed and yet have chosen to be preoccupied with the Liberation of Barotseland, but they are welcome, as we have no doubt that they will learn as they move along.

It is a matter of record that from the time Mutompehi Wainyae Sinyinda was installed as Ngambela of Barotseland right through to his assuming leadership of the BNFA those who live in dreamland of fantasy and fancy themselves as 'true' liberators of Buluzi have had unceasing nightmares driven by petty jealousy. They are troubled by the fact that someone else, and not themselves, is receiving attention as the center of leadership. Mutompehi Sinyinda's arrest by Zambian Police was decided upon much earlier than it happened, but the problem of the enemy was one of finding a suitable offence on which to charge him. This was because the real reason for persecuting him, being the fact that he presided over the 27 March 2012 Barotse National Council and follow up implementation of its resolutions, could not be used to evolve chargeable grounds because they were fundamentally legitimate actions under both Zambian and international law. The opportunity to actually arrest him arose out of the childish action of the Mombotwa led Linyungandambo's fake declaration of independence, and there is no doubt that the real intention of that act was to create a reasonable environment for the arrest of

Mutompehi Sinyinda. Is it not a wonder that the real architect of that childish act has never been arrested? Who is the real agent of the enemy in this scenario?

Many accusations have been leveled against Mutumpehi Sinyinda and his fellow BNFA leaders by the Linyungandambo through their mouth piece, the Barotse Post, particularly in the last twenty-four hours. These actions portray immense desperation on the part the perpetrators and their sponsors. However, it is not the BNFA's intention to give credence to this ill conceived and ill fated scheme through point by point rebuttal as it will be sorted out by time. As stated already we have no doubt that properly grounded people will not be swayed by the rubbish being churned out and, as the proof of the pudding lies in its tasting, the truth in the charges will come to pass through the happening, or non happening of the predictions. In this respect we await to see the appointment of Mutompehi Wainyae Sinyinda as Vice President of the Republic of Zambia, as per prediction of Nayoto and his Linyungandambo childish dreamers. Meanwhile, they are free to continue dreaming but should also be aware of the consequences.

Finally, the BNFA Executive Committee has no policy of playing to the gallery as this should be left to those who are not sure of their capability to perform, and believes that only **taba ye buzwise** should be churned out to the public. Meanwhile, it is a fact of life that the best way of demonstrating someone's shallowness of mind is to allow them time and space to perform in public, rather than attempt to describe their incapacity in your own words.
