: HIS ROYAY HIGHNESS THE LITUNGA LUBOSI IMWIKO II RE: MONGU TRUTH AND RECONCILIATION SUMMIT OCTOBER 2014

CONTENT: The bone of contention is that, despite Zambia having championed herself as the most peaceful and politically stable country on the continent of Africa, one issue still clouds this image and refuses to go away; and that issue is the Barotseland Agreement 1964.

Although the Barotseland Agreement 1964 was entered into and signed in good faith by all the parties concerned (at the dawn of our independence) on the 24th May, 1964 the Zambian government failed to fulfill its obligation of interpreting the Barotseland Agreement of 1964 and translating it into a reality as a backbone of the national motto of "One Zambia, One Nation" after the attainment of independence, which ushered the unitary and indivisible sovereign state of the Republic of Zambia. This was due to none scrutiny of the original agreement signed by Queen Victoria and King Lewanika, which was revoked on 18Th April, 1964 by transfering the responsibility of welfare of the then "Barotseland Protectorate" from the British Government to the incoming self-government of the Republic of Zambia.

Ilowever, after attainment of independence on the 24th of October 1964, there followed a succession of Acts of Parliament, such as the Local Government Act No. 69 of October, 1965 which took away the powers and privileges of King Lewanika the Litunga over the ruling of Barotseland, thereby naming the region Barotse Province. Followed by the Λugust 1969 Λct that renamed the Barotse Province as Western Province which eventually took away the residual powers of the Litunga, such as powers over forestry, lands, wildlife, fishing and national parks; and the 1970 Act Number 47 abolished the Barotseland autonomic governance of His Majesty King Lewanika the Litunga of Barotseland, naming him Paramount Chief Lewanika. Finally, on 18th August, 1993 the Zambian government through the office of the Minister without Portfolio Hon Brigadicr General Godffrey Miyanda, declared the Barotseland Agreement of 1964 as null and void, citing the reason that the agreement had gone stale "due to the passage of time," a statement that curtailed any further dialogue and negotiation on Barotseland Agreement of 1964 between the government of the Republic of Zambia and the Barotse Royal Establishment. This infuriated the Lozi people and gave rise to the Barotseland Freedom Movement Groups such as the Linyungandambo etc.

Consequently, on the 14th of January 2011 before PF government came into power, there occurred disturbances in Mongu, regarding the Barotseland Agreement of 1964, which led to unprovoked killings and arrests of innocent youths by allegedly Zambian police.

But during the campaign that ushered in PF government, it is strongly believed that President Michael Chilufya Sata promised that, if voted in power he would restore the Barotseland Agreement of 1964 in 90 days' time, after all he (President Michael Chilufya Sata) was a member of the Linyungandambo Freedom Movement himself, a statement which was substantiated by the President's own invitation of the Linyungandambo Freedom Movement Group to State House within 90 days in power, whose agenda was unknown to Barotse Royal Establishment. This further caused suspicion among the Lozi people because the BRE was not involved in these discussions.

Later on the Republican President H.E Michael Chilufya Sata, not only appointed the Roger Chongwe Commission to investigate the Mongu uprising of the 14th January, 2011 but also ordered the publication of the full text of the Barotseland Agreement of 1964 in the public media for the very first time ever since independence. When the Chongwe Commission presented its findings to the President, the President refused to announce to the nation what was contained in the Rodger Chongwe Commission Report, thereby downplaying the Barotseland Agreement of 1964, citing the reason that the Barotseland Agreement of 1964 was not in the terms of reference; therefore, the Roger Chongwe Commission acted beyond its powers.

This further annoyed the Lozi people and the Barotseland National Council was re-instituted and sat at Mongu whose resolution was for Barotseland to secede from the Republic of Zambia; this was in March, 2012. The same civil disobedience took place in a similar fashion in Mongu on the 9th September, 2012 which also led to killings of innocent youths and massive arrests by the Zambia Police which only ended up in nolle prosequi in the High Court of Zambia.

In the circumstance, therefore, as we prepare for the Golden Jubilee of our independence and the nation approaches this mammoth independence Golden Jubilee, we feel it is the opportunity to bring this matter to a meaningful close; and this can only be achieved through a process of honest dialogue and negotiation through sincere exchange of views from all parties concerned at this highest public level.

It is in this spirit that cordial invitation is extended to the President of the Republic of Zambia H.E Michael Chilufya Sata together with His Royal Highness the Litunga Lubosi Imwiko II to attend the Mongu Truth and Reconciliation Summit proposed to be held in Mongu in October, 2014 before the celebration of the Golden Jubilee. Other delegates shall include the Barotse Royal Establishment (BRE), all the Barotseland Activist Groups, all traditional leaders of Western Province tribes, all church mother bodies including those opposed to Christianity, representatives of all organizations including the civil society organizations. Diplomats accredited to Zambia, Members of Parliament, Members of House of Chiefs and invited guests as per Mongu Peace and Unity Declaration Addendum attached hereto.

OBJECTIVE: The aims and objectives of this "Mongu Truth and Reconciliation Summit 2014" are to truthfully and honestly debate the Barotseland Agreement of 1964 which is

currently non-functional, in order to reach a meaningful and logical conclusion, after exhausting the controversy to consider the problem of lack of a meaningful developmental performance which the area has suffered in comparison to other provinces since independence. Supplicate for peace and unity from His Royal Highness the Litunga, under most humble request for the Litunga to unify the nation under our national motto of "One Zambia, One Nation," for the name "Lewanika" means the unifier.

VENUE: The venue of this historic event has deliberately been chosen to be in Mongu the Headquarters of the Western Province of Zambia in order to make this Summit historic to our posterity by making it possible for all the Western Province traditional leaders and residents to attend the summit.

CONVENERS: The convening of this historic event and the fundraising shall entirely be the responsibility of a Zambian led organization called "Agape Associates Conflict Solutions" in conjunction with all sane and Right-Thinking Zambian citizens, peace loving corporate bodies and other international peace seeking countries and organizations who have been following the sad developments regarding the Barotseland Agreement of 1964 that has existed for fifty (50) years now since independence.

RESOLUTIONS: It is our hope and belief that the deliberations and resolutions which will come out of this historic Summit will be binding and issued out as the "Mongu Peace and Unity Declaration" to replace the dysfunctional Barotseland Agreement of 1964. In the circumstance, therefore, we request the President of the Republic of Zambia H.E Michael Chilufya Sata and His Royal Highness the Litunga Lubosi Imwiko II to accept our invitation in person at this historic summit and declare for peace and unity of the country by signing the Mongu Peace and Unity Declaration document thereafter.

CONCLUSION: The details for the dialogue and debate to resolve the Barotseland Agreement 1964 are contained in the agenda for the Mongu Truth and Reconciliation Summit of October, 2014 as highlighted in the supplementary document attached hereto.

PREAMBLE:

Please, kindly be informed that this is the sole essence of the "Mongu Truth and Reconciliation Summit of October, 2014" to revitalize the peace and unity that has existed for the past fifty years; and then declined to almost turmoil as evidenced by the recent Mongu uprising.

Your Royal Highness the Litunga Lubosi Imwiko II, are the factor for the well being of our country Zambia a Christian Nation, which should have Christian Principles such as: forgive each other, love one another, vengeance is for God, pray for those who persecute you etc. For this reason, Your Royal Highness, forgive them for they do not know what they are doing; and these are both the Government of the Republic of Zambia and Linyungandambo Organization of Mr. Sinyinda the former Ngambela who is currently pausing as the Prime Minister of Barotseland under the guise of the Barotseland Agreement 1964.
