We the undersigned representatives of the Barotse Royal Establishment and political organisations comprised in the BNFA hereby confirm the endorsement of the "Evidence and Arguments" submitted to the Commission in accordance with Rule 113(2) of the Rules of the Commission.

In particular we reiterate the main prayer of our Petition to the Commission, being that the Commission determines as follows:-

- (a) The people of Barotseland's right to self-determination as enshrined under Article 20 (1) of the African Charter has been violated by the Respondent State.
- (b) The Respondent State should cease to administer Barotseland, and
- (c) The Respondent State immediately engages the Applicant peoples' institutions with the sole purpose of working out modalities for the handover of the administration of Barotseland within the shortest possible time under the auspices of the African Union and the United Nations.
